#### **General Information**

Note: The Club By-Laws state that all dues and fees must be paid by March 1<sup>st</sup> of each year. Be sure to take advantage of the \$25 discount by paying before February 1<sup>st</sup>, 2025.

If your boat is waterborne on Pennsylvania waters more than on waters of another state, it must be registered in Pennsylvania regardless of where you live. Excluded: canoes, kayaks & dinghies. By signing this form, you are confirming you have a valid PA registration on any powered boat left on club grounds.

Under the terms of our lease with the State of PA, our club is required to issue and collect fees for the State Mooring Decals for all off-shore, shoreline, on-shore, and trailer moorings. All watercraft left overnight on club property must have a decal. You will be able to purchase extras throughout the year. **All watercraft of any size must have a decal, this will be strictly enforced in 2025.** 

Members must carry liability insurance on their boat either as part of the homeowner's policy or as a separate policy. **By signing this form, you are verifying you have the proper liability insurance.** You are responsible for any damage to other boats. Check your car insurance concerning boat towing. Please enter insurance information in the space provided above.

If there is a change in any of the above information during the year, please notify the Club Secretary in order to keep all records and mailing lists up to date.
